**<u>Clarification #1:</u>** The following addition will be made to the master services agreement for planning / environmental consulting services:

#### 7.22 Errors and Omissions

If during the construction of a project designed by the Consultant, there are required design updates, changes, clarifications, or construction change orders that are due to inaccurate or incomplete drawings provided by the Consultant, the District may issue a Potential Back Charge Notice (see Exhibit \_\_\_) to the Consultant. A Potential Back Charge Notice indicates the Districts' intent to potentially hold the Consultant liable for any and all costs associated with the item/issue outlined in the Potential Back Charge Notice.

The exhibit referenced above will be distributed to the highest ranked firms post interview.

- <u>Question #1:</u> Section 7, item 7.1 Insurance states: 'Consultant and its Sub-Consultants shall, at its sole cost, obtain and maintain for the duration of the contract, insurance of the following types with limits not less than those set forth' (listed in the RFQ). Will the District accept a lower insurance level for specialty subconsultants expected to perform limited services/liability efforts?
- **Response #1:** The District requests for the insurance to be provided as outlined in the RFQ.
- **Question #2:** When was the last Master Plan, ALP, update made?

Response #2:	The most recent master plan for the airport was the Wingspan
	Master Plan encompassing the period from 2020-2040 and can be
	found on the GSP Airport website. The Airport Layout Plan was
	updated in 2021. We are currently updating the plan for FAA submittal within the next 30 days.
<u>Question #3:</u>	According to the RFQ description on the first page – can you sub out part of or all services?

- **Response #3:** The District is interested in the most qualified team to support the CIP and rely on each firm/team to determine the make-up of that team.
- <u>Question #4:</u> Are there any limitations on teaming expectations related to the two SOQs (architectural/engineering and planning/environmental)?
- **Response #4:** The District will allow a firm to serve as prime on either the P/E master agreement or the A/E, not both.
